It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered from an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK

There is a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. Participants must understand that depending upon the activity, certain risks, dangers and injuries due to acts of God, inclement weather, slipping, falling, inadequate or defective equipment, failure in supervision or instruction, premises defects, horseplay, carelessness, lack of skill or technique, and all other circumstances inherent to outdoor recreational activities/programs exist. Outdoor activities at Why Not Now? may bring participants into contact with water, wildlife, plants and weeds and the risks inherent in such contact.
